

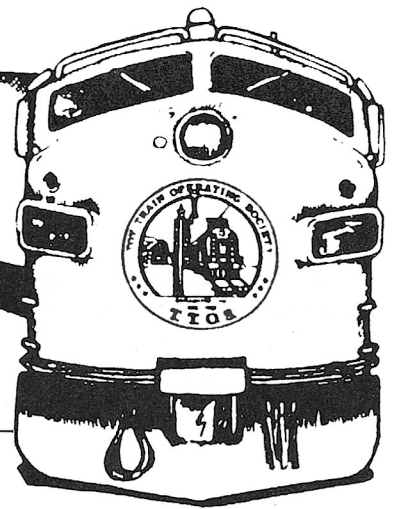

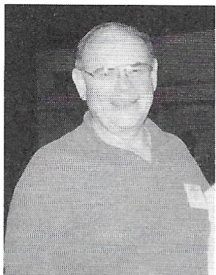

# Disney animator donates trains to railway museum



**WARD KIMBALL #652HL**

PERRIS (AP) -- When Disney animator Ward Kimball wanted to put together a train set, he thought big: His first purchase was a 22-ton, 1881 locomotive he picked up in 1938 for \$500.

It became the cornerstone of a full-size backyard railroad valued at more than \$1 million. Now, Kimball and his wife have decided to give up their rare toys, and a railway museum is the beneficiary.

Two narrow-gauge locomotives, a cattle car, freight cars and more are becoming part of the Orange Empire Railway Museum in Perris, about 70 miles southeast of Los Angeles.

Kimball, 78, the creator of Jiminy Cricket and longtime friend of Walt Disney, will be honored Saturday in a ceremony marking the new home of the "Grizzly Flats Railroad" he put together at his 3-acre San Gabriel home.

A passenger coach and other cars were shipped to Perris last week, and the 1881 locomotive will be shipped in November. Kimball and his wife, Betty, are donating more than \$135,000 for a building to house the collection.

"We have to do this gradually," said Mrs. Kimball. "We become depressed with all the stuff leaving."

One smaller, 9.5-ton locomotive, built in 1907, will remain at the Kimball home in San Gabriel a few more years. A separate collection of antique railroad toys, one of the largest in the world, is not being donated.

Kimball, 78, joined the Disney staff at age 20 and became a full-time animator two years later.

He worked on many Disney short films as well as cartoons, movies that included "Snow White," "Fantasia," "Pinocchio," "Dumbo," "Cinderella," "Alice in Wonderland" and "Babes in Toyland."

Kimball has been a railroad buff and collector since his childhood, when his family traveled from Minnesota to Kansas by train.

The artist and his wife, who also worked at the Disney studios, began collecting locomotives and rolling stock when the equipment was considered obsolete and was being dismantled and sold as scrap.

Many of the pieces are irreplaceable today, and collectors scour Central and South America for similar models.

The 1881 locomotive, which was bought just before it was to be cut up and set to Japan, was the last locomotive to run on the Nevada Central Railroad. The Kimballs bought an 1881 passenger coach the same year for \$50.

The Kimballs' donation is the largest to the museum by an individual or a couple, said spokesman Paul Hammond. Some of the pieces will be among the oldest in the museum, he said.

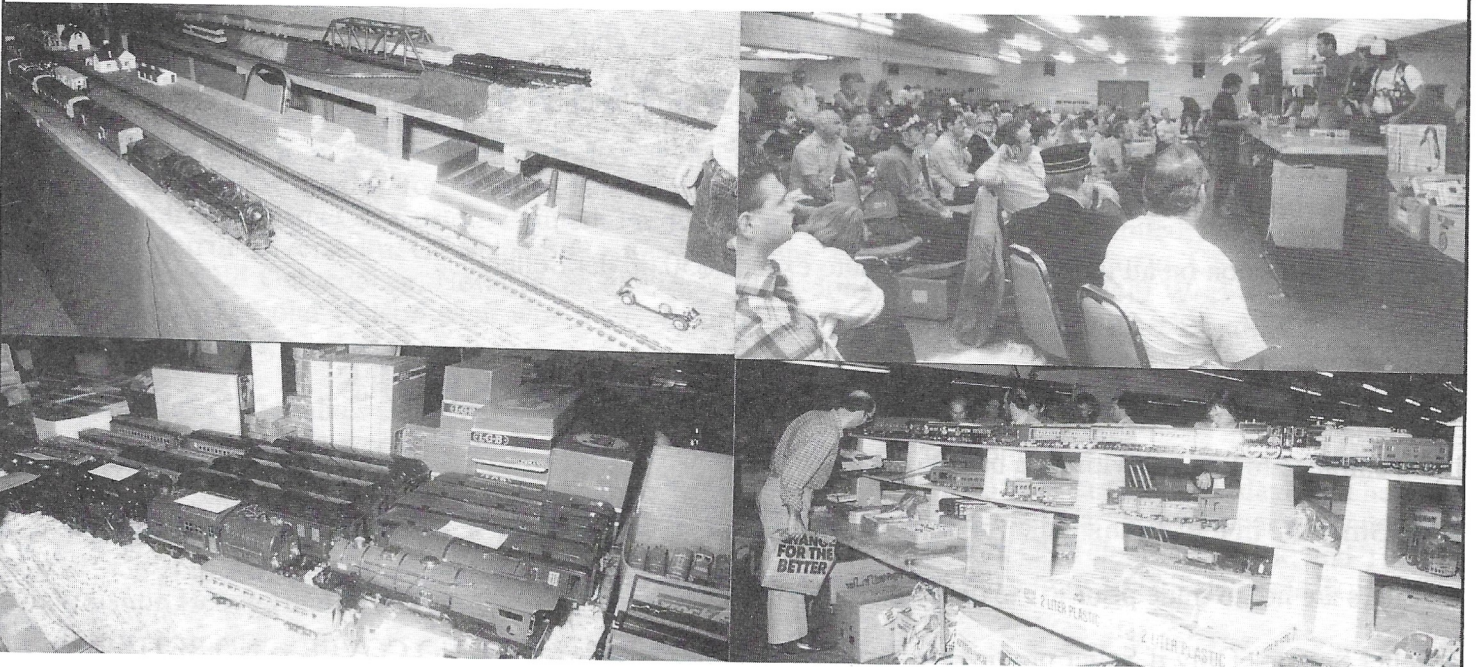

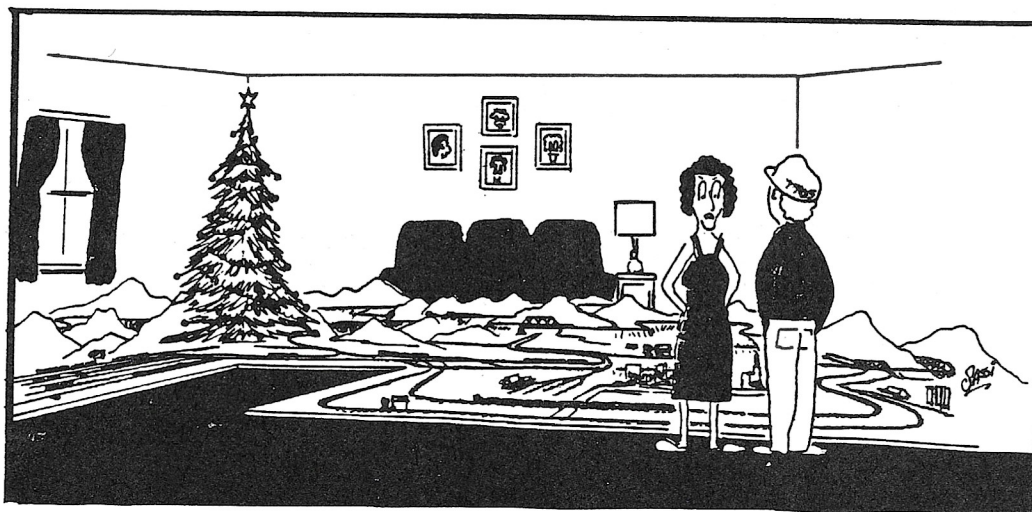

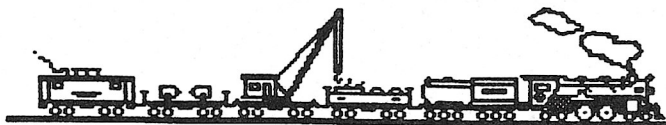

The Chapter provides ongoing and generous support to the Museum's research library with the gift of one copy of each new title received by Milepost 1. ■ An 1888 lithographic map of Alamitos Bay (Los Angeles County) showing surrounding railway lines, and a Central Pacific Railroad 1881 season ticket. Donated by Foundation director Wendell Hammon. ■ Two brass locomotive gauge lamps, dating from the 1870s-

1880s. Received from James E. Higman. ■ Photographs, certificates, documents and other papers relating to the career of Edward J. Engel (1874-1947), president of the Atchison, Topeka & Santa Fe from 1939 to 1944. Presented to the Library by his daughter-in-law, Mrs. E. K. Engel. The collection includes two albums of photographs of the Santa Fe circa 1925-1940, compiled by J. W. Barriger III, scrapbooks and testimonial resolutions from the Santa Fe and other railroads. ■ Over eighty black and white negatives of the Southern Pacific, Western Pacific, Mt. Tamalpais & Muir Woods and Bay Area electric railroads, circa

1914-1918 taken by C. L. Mason, telegraph operator for the Southern Pacific and Western Pacific, and a Key System motorman. Presented to the Library by his son, Charles L. Mason. ■ Thirty hand lanterns and marker and car lamps, along with locks, keys and other artifacts from North American railroads. Donated to the Museum by railroad historian and author Jesse Condé. ■ Fifty-five nineteenth-century photographic views of the Atlantic & Pacific Railroad at Needles, California and other locations by locomotive engineer Percy Adrian Dunn from the collection of his daughter, A. Eleanor Dunn. ■

Keep up the good work!

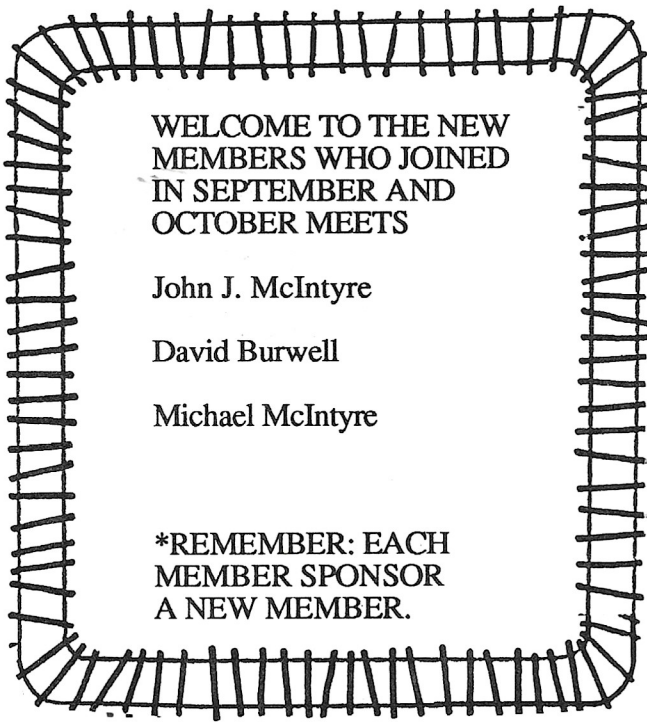

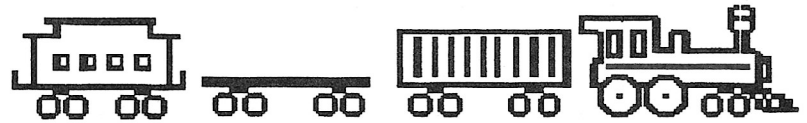
