

## SWD BOARD OF DIRECTORS MEETINGS

Starting in January, 2022, SWD started having its Monthly Board of Directors Meeting at the Arcadia Masonic Center immediately following the conclusion of the Monthly Meet Auction. This is an attempt to get better participation from the Board members as well as for the SWD membership.



The January and February Meetings were a success and so we plan to continue holding our Board Meetings after the Monthly Meet Auction is concluded. We use the auction tables and chairs for our Meeting. I will have printed agendas available at this Meet. Ask me for a copy at the Meet if you are interested

in attending. The agenda is four pages long and tells you who the officers are and what they do, as well as information on everything we do and how we do it. Our monthly Board Meetings normally last about one hour, barring lengthy discussions. Please get involved. We need younger Board Members.

## TAX MAN COMETH

The American Rescue Plan, the Biden Administration's \$1.9-trillion COVID-19 relief bill, has made some tax changes that many of our Members need to know about. The bill was funded mainly with borrowed money, but it also seeks to improve income tax compliance by lowering to \$600 the threshold for income reporting by "third-party settlement organizations." The change affects such companies as PayPal, eBay, Etsy, Venmo, and Airbnb. What this means is, for example, if you use PayPal to handle eBay sales over \$600 during the 2022 tax year, Pay Pal could issue you a 1099-K in the amount of your sales during 2022. The IRS receives a copy of this and will expect you to include the money reported on the 1099-K in your gross income on your federal tax return. Sale proceeds aren't necessarily profits and only profits are supposed to be taxed. You will have to file a Form 8949 to show that some or all of the 1099-K amounts did not produce taxable gains. Also, if you can prove that you lost money on your transactions, you can **not** claim the losses against your income, unless you are a

business. This information will also be reported to the State of California, which also collects income tax on this kind of profit. The only way to avoid this is to pay by credit card, check or cash. This is another advantage to buying and selling your trains at our Monthly Meets.

This information came from an article in The Los Angeles Times, "Tax man cometh for Venmo, PayPal users," 2/11/22, page A8.

Another recent development is that eBay now charges you local sales tax on your purchases, even if out of state. That adds 10% more to your purchases unless you have a resale permit on file with eBay. This is expected to be applied to sales at out-of-state auction houses.

Things could get much worse if Biden's \$6-trillion Build Back Better bill gets passed. Banks will have to report all transactions in excess of \$300 to the IRS. The banking industry is very upset about the prospect of having to deal with this. This bill also funds 85,000 more IRS agents to manage the additional work.





## Ted Trisler: 1939 - 2021

Pastor Ted Trisler had many great passions in his life. He led the Puente Hills Baptist Church for 42 years. He loved his late wife Sharon, and the family they shared, including his son, who pre-deceased him, his two daughters, six grandchildren and seven great-grandchildren. Ted drove collectible cars and was a big Elvis Presley fan.

But for those of us who knew "Teddy" at the Southwestern Division Meets, he had an *extra-special* passion: toy trains!



Ted attended the SWD Meets right after he finished church on Sunday, and he always looked his best. He had been in good health, but a fall late last year changed everything. He had a brain hemorrhage, complicated by a staph infection known as MRSA, and died after a short time in a rehab facility.

Ted's memorial service, on January 21, 2022 was the sort of funeral that many toy train enthusiasts might wish for. Surrounded by a hundred or more of his best friends and family, Ted's coffin was adorned with a tapestry of trains, including a large illustration of a Pennsylvania Railroad GG-1. Atop all that was a plexiglass case containing a Lionel Super-Detailed Hudson, 700T tender and a New York Central caboose, all of them plated in 14K gold, on a walnut base. *Now, that was a send-off!*

After Ted passed away at age 82 on December 20, 2021, the family had to decide what to do with all those trains. So, an estate sales organization was contracted to conduct a 3-day event during the second weekend of February.

Flyers were handed out at the February 6th SWD Meet. Turnout was robust and the trains soon found new homes around Southern California. Ted collected Lionel, Flyer, Marx, the big LGB and the little HO & N gauges. He loved them all....


